### HOW TO ENTER

To be eligible entrants must complete the following:

- a) Register for Online Banking by
  - (i) Registering for the first time in branch or via the phone by calling MyState Bank on 138 001 (local standard call charges apply) OR;
  - (ii) Being automatically registered for Online Banking for the first time by opening a new transaction or savings account online as a new customer OR;
  - (iii) Being registered for the first time by a MyState Bank representative for any reason, AND;
- b) Download and login to the MyState Bank Mobile App for the first time, from the Google Play Store <https://play.google.com/store/apps/details?id=com.mystate.app> or the App store <https://apps.apple.com/us/app/mystate-bank/id927122309>, within;
- c) The promotion period.

### CONDITIONS – PARTICPATION

1. This competition ("Competition") is conducted by MyState Bank Limited (MyState Bank) ABN 89 067 729 195 AFSL 240896 a wholly owned subsidiary of MyState Limited ABN 26 133 623 962 ("Promoter").
2. Entry to the Competition constitutes acceptance of these conditions. All entry instructions and prize information published by the Promoter form part of these conditions.
3. The Competition commences at 9:00am AEDT on Thursday 6 February 2020 and closes at 5:00pm AEST on Wednesday 6 May 2020 ("Promotion Period").
4. The Competition is only open to Eligible Entrants. An "Eligible Entrant" is an individual who: (i) is a Tasmanian or Queensland resident; and (ii) over the age of 18 years; and (iii) is a current MyState Bank customer at the time of the draw, and has never previously registered for MyState Bank Online Banking or logged into the MyState Bank Mobile App and successfully completes both of these actions within the promotion period.
5. Employees and directors of the Promoter and its related companies, their immediate families, and retailers, suppliers and agencies associated with the Promotion are ineligible to be Entrants.
6. Entries are deemed to be received at the time of receipt into the Promoter's database. The Promoter is not responsible for any delay in, or failure of, transmission which causes an Entry not to be received within the Promotion Period. Incomplete, indecipherable or illegible Entries will be deemed invalid.

## ENTRY GENERAL

7. Competition entry is limited to one entry per individual. Where an individual has multiple customer accounts and meets the eligibility criteria on each of these accounts, only one entry per individual will be valid.
8. All entries to the Competition may be subject to verification by the Promoter.
9. The Promoter may, at its absolute discretion, declare any or all entries made by an entrant invalid if the entrant: (i) fails to establish their entitlement to enter the Competition to the Promoter's satisfaction; or (ii) fails to produce items as required by condition or produces items that, in the Promoter's opinion, are illegible, stolen, forged, reconstructed, altered, incomplete or tampered with in any way; or (iii) in the Promoter's opinion, tampers with the entry process or benefits from such tampering; or (iv) in the Promoter's opinion, submits an entry which is not in accordance with these conditions.
10. An entry by more than one person (i.e. a joint entry) is invalid.

## WINNERS

11. There is one opportunity to win, with the winning entry randomly drawn by a representative of MyState Bank.

13. The winning entrant will be notified by telephone within two business days of the Prize Draw and will receive written confirmation within fourteen days with details of how to claim their Prize and the date by which they must claim their Prize ("Prize Claim Date").

## PRIZE
