

# MyState Bank - Win Free Groceries for a Year

## Conditions of Entry

1. By entering this **Promotion**, Entrants agree to abide by these Conditions of Entry.
2. The **Promoter** is MyState Bank Limited (MyState Bank) ABN 89 067 729 195 AFS Licence Number 240896. A wholly owned subsidiary of MyState Limited ABN 26 133 623 962, Telephone 138 001
3. The Promotion commences at 9:00am AEDT on Monday 18 March 2019 and closes at 5:00pm AEST on Thursday 18 April 2019 (**Promotion Period**).
4. An **Entrant** is any Tasmanian or Queensland resident aged 18 years of age and over that successfully completes an Entry. Employees and directors of the Promoter and its related companies, their immediate families, and retailers, suppliers and agencies associated with the Promotion are ineligible to be Entrants.
5. To enter the Promotion, Entrants must take out a new Qualifying Insurance Policy at any MyState Bank branch, on the MyState Bank website or by calling 138 001 during the Promotion Period, Insurance issued by Insurance Australia Limited ABN 11 000 016 722 trading as CGU Insurance (**CGU**) of Tower 2, 201 Sussex Street, Sydney, NSW. The Entrant will then automatically be entered into the Promotion (**Entry**).
6. The Qualifying Insurance Policy must be paid in full (or in the case of Pay by the Month Policies, the first instalment payment must be received) and the policy current at the time of prize draw. The issue of a Qualifying Insurance Policy is subject to CGU's underwriting guidelines.
7. A Qualifying Insurance Policy Is:
  - a. Home and Contents Insurance
  - b. Car Insurance
  - c. Travel Insurance
  - d. Landlords insurance
